FURTHER CLARIFICATION JOINT ANNOUNCEMENT

- Resignation of executive director of CASH

- 1. The resignation of Mr Wong as an executive director of CASH was due to his other commitment.
- 2. Mr Wong, as a non-executive director of CFSG, is entitled to a director's fee of HK\$100,000 per annum as specified in the appointment letter. His remuneration is fixed by the board of directors of CFSG with reference to his duties and responsibilities with CFSG.
