On 23 July 2010, the Company, Cash Guardian Limited (“Cash Guardian”, the controlling shareholder of the Company) and Celestial Securities Limited (“Placing Agent”) (a non-wholly-owned subsidiary of the Company) entered into a placing and top up agreement pursuant to which the Placing Agent agreed to place 20,000,000 existing ordinary shares held by Cash Guardian to not less than six placees at a placing price of HK\$2.50 per share. According to the agreement, Cash Guardian has conditionally agreed to subscribe for 20,000,000 new top up ordinary shares of the Company at a top up price of HK\$2.50 per share.
